- Election of candidates for the Board of Managers is conducted at the Annual Meeting each year (OA, section 7.7)
- The election is conducted by secret ballot (Manual 34, section 11.11)
- Members expressed preference is that PJM not have access to see their ballots
- PJM investigated a solution for Board elections that ensures continued confidentiality and secure sector-weighted voting results and began using a thirdparty vendor for Board elections beginning in 2021.

- Only one ballot will be accepted per Voting Member company
- Election closes after 45 minutes and any voter issues resolved

## **After Election**

Results reported at MC



# Conduct of Election at May 1 MC Meeting

- 11:30 AM SBS sends voting links to eligible voters
- 1:00 PM Meeting begins
- ~1:15 PM Vote is open in app
- ~2:00 Vote closes in app
- ~3:00 SBS provides result, announce in MC
