

Congestion Management Process / Freeze Date

- CMP members continues to meet on a regular basis working through Freeze Date data analysis
 - Next CMP working group meeting 3/14/24
 - Next CMP Council meeting 2/21/24



- MISO presented counterproposal to CMP collaborated solution at JCM
 - Focus on Firm Flow Entitlements
- TVA preparing presentation for proposal of Firm Flow Limits



Freeze Date FFE / FFL

- Firm Flow Entitlements (applies to market entities)
 - SPP continues to review MISO counterproposal and perform additional analysis. Timeline updated to review during March CMPWG.
- Firm Flow Limits (applies to non-market entities)
 - TVA renewed focus on firm flow limit proposal and reviewed initial proposal during November 30th CMPWG. Additional analysis shared during January 25th CMPWG. All entities reviewing proposal



Interregional Planning

- PJM MISO Interregional Stakeholder Advisory Committee 3/1/24
 - Annual Issues Review
 - Existing and new regional issues along PJM/MISO seam
 - Newly approved projects near PJM/MISO seam
 - M2M historical congestion
 - Joint RTO Planning Committee
 - Within 45 calendar days after the Issues Review IPSAC the JRPC shall determine the need for a Coordinated System Plan study



Interregional Planning Key Dates

- Stakeholder input due: January 31, 2024
- Annual Issues Review IPSAC: March 1, 2024
- JRPC determines whether to perform a CSP study in 2024
 - April 15, 2024 (at the latest)
 - JRPC will inform IPSAC within 5 days of the decision
