### 1. RECOMMENDED PROPOSAL

The proposed package addressed four design components. The proposal includes the following solution options:

- Keep status quo for Minimum Downtime and Notification Time parameters for Economic Demand Response (DR) resources.
- Make available Maximum Downtime and Minimum Release Time parameters for Economic DR.
  - Maximum Downtime addresses the maximum number of contiguous hours for which a DR bid can be cleared/dispatched in the energy market.
  - Minimum Release Time addresses the minimum number of contiguous hours that must elapse from a DR resource release and its next curtailment commitment in the energy market.
