#### Administration

- 1. The Operating Committee (OC) Agenda for this meeting was **approved**.
- 2. The Draft Minutes of the June 5, 2018 OC meeting were approved.
- 3. The Operating Committee Work Plan was reviewed. PJM will continue to solicit input from stakeholders regarding future OC agenda items.
- 4. Mr. Tom Zadlo, PJM, provided a reminder that flat files will no longer be posted on the PJM website. This data is available from the Data Miner application on pjm.com.
- 5. Mr. Don Wallin, PJM, provided an update on the University Park North RAS/SPS status. Work has been completed under eDART ticket 749273 and University Park North RAS/SPS is retired.
- 6. Mr. Don Wallin, PJM, reminded the OC that the materials from the June 25 OC/PC Special Session for Manual 21 Changes are posted on the OC webpage.

PJM will provide more information on the 6/4 synchronized reserve event at a future OC meeting. PJM will also review how the PCLLRW monthly data is presented and consider better ways to present the data.

#### 9. 30 Minute Reserve Proposal Update

Mr. Vince Stefanowicz, PJM, provided an update regarding PJM's 30 minute reserve proposals. The Operating Committee **endorsed** by acclamation the base 30 minute reserve requirement calculation methodology (2018 requirement of 3784 MW) and the methodology for adjustments to the base requirement with 0 objections and 48 abstentions.

Ms. Diane Lake, PJM, reviewed the proposed changes to Manual 3A: Energy Management System (EMS) Model Updates and Quality Assurance (QA). The Operating Committee **endorsed** by acclamation the proposal with 0 objections and 0 abstentions.
