Appendix 1 to PJM Pro Forma 3-Party Interconnection Related Service Agreements

- Definitions for most of the PJM pro forma 3-Party interconnection related service agreements are found in Appendix 1 thereof
 - Presently, PJM incorporates into Appendix 1 of these agreements the entire Tariff, Part I, section 1, Definitions (not a Commission or Tariff requirement)
 - Equals about 103 pages and about 614 defined terms
 - Most defined terms are not even mentioned within PJM's pro forma
 3-Party service agreements
 - Any changes made to defined terms while a PJM pro forma service agreement is out for execution results in a need for replacement pages to such service agreement

Appendix 1 to PJM Pro Forma 3-Party Interconnection Related Service Agreements

- Many defined terms in Tariff, Part I, section 1, Definitions are subject to frequent changes (as part of Tariff market and operation rule changes, etc.)
- Recently, as a result of such changes, as many as 46 replacement pages were required for an interconnection service agreement (approval required while on a 30-day Commission regulatory filing clock)
 - 36 of 46 pages had changed terms not present in ISA body
 - While parties may provide email consent, parties' review and approval still required

Appendix 1 to PJM Pro Forma 3-Party Interconnection Related Service Agreements

- In response to various concerns, effective September 1, 2020, PJM is changing its process to only incorporate into Appendix 1 those defined terms from PJM Tariff, Part I, section 1 that are actually used in the PJM Pro Forma 3-Party interconnection related service agreements
 - Reduces defined terms from about 614 to about 117 terms (see posted redline of ISA definitions section and clean streamlined ISA template)
 - Change will reduce the number of Appendix 1 pages impacted during the conformance review stage (resulting in fewer replacement pages)
- PJM is also including in transmittal emails to developers and TOs more details explaining revisions resulting from conformance reviews and specific (rather than general) reasons for such changes
