### 2. Pseudo-Tied Generators and Dynamic Schedules End-of-Month Meter Correction

The Subcommittee reviewed the updates to the Pseudo-Tied Generators and Dynamic Schedules End-of-Month Meter Correction Matrix. Additional solution options were discussed and a preferred package was agreed upon.

At the March 8 MIC meeting, PJM will provide an informational update on the work performed during the January and February 2017 MSS meetings and present the proposed solution package as defined in the matrix.

At the March 16 MSS meeting, PJM will review the proposed red-lined changes to Manual 28 and the OATT with respect to the proposed solution. At the meeting, PJM will seek feedback and approval on the proposed changes.

At the April 12 MIC, PJM will present the proposed solution and red-lined Manual 28 and OATT changes as a first read.
