

# Planning Committee PJM Conference and Training Center, Audubon, PA February 11, 2016

### Administration

- 1. Mr. Steve Herling called the meeting to order and asked if the Planning Committee had any additional items for the agenda. There were no suggestions for additional agenda items.
- Mr. Herling asked Ms. Bridgid Cummings to review the meeting minutes of the January 7, 2016 Planning Committee meeting. Mr. Herling asked the Planning Committee to approve the minutes. Mr. John Kopinski made a motion to approve the minutes. Mr. David Pratzon seconded the motion. In a voice vote, the Planning Committee approved the January 7<sup>th</sup> Planning Committee Minutes.

#### Informational Updates

3. NERC/RRO Update

Mr. Bill Temple provided an update to the Planning Committee on recent NERC activities and PJM compliance activities. The Periodic Review Team voted to retire BAL-005-1 once BAL-006-2 becomes effective and to add sub-requirements to requirements of FAC-001-2. Comments and ballots for on-going standard reviews can be found under the January 7<sup>th</sup> Planning Committee Material. ### 4. RTEP Proposal Window Update

Mr. Michael Herman presented an update on the RTEP Proposal Window implementation and communication enhancements. Resources regarding contact information, 2016 RTEP Proposal registration, and Axway registration materials can be found under the January 7<sup>th</sup> Planning Committee Material at the <u>Planning Committee Website</u>. The files for the 2016 RTEP Proposal Window are preliminary at this time. The proposal windows 2 and 3 will be similar in scope and timeline as those for 2014 and 2015.

### 5. Order 1000 Lessons Learned

Mr. Frank Koza discussed plans for restarting the Special PC Session, Order 1000 Lessons Learned meetings. The first meeting will be held on February 23, 2016 from 1pm to 3pm at PJM. The initial focus will be to discuss adding transparency to the RTEP proposal process.

### 6. <u>Sunset Phase Angle Regulator TF and Long Term Firm Transmission Service TF</u>

Mr. Aaron Berner discussed the work of the Phase Angle Regulator Task Force and the Long Term Firm Transmission Service Task Force. Mr. Berner discussed that these groups had accomplished their goals. The two task forces were approved to be sunset. Updates to PJM Manual 14E,



identified as separate from the PARTF requirements, are still being conducted but will be brought to the Planning Committee within the next few meetings.

### 7. MOD 32 GEN Portal Review

Mr. Jonathan Thompson provided a review of MOD-032-1 and the MOD-032 Gen Portal developed to support compliance. The effective date of MOD-032-1 Requirement 2 is July 1, 2016. The pilot is currently available for use for generation owners looking to gain experience and provide feedback. Any Independent Power Providers are also encouraged to participate in the pilot. Please contact MOD-032@pjm.com with questions and feedback. The Gen Model will open for MOD-032 business for 2016 submissions on May 1, 2016 and will close on July 31, 2016. ## 8. CIP 002 and CIP 014 Process

Mr. Tom Kay, Commonwealth Edison Company, facilitated a discussion of the PJM Assessment Process and Process Timeline related to CIP-002 and CIP-014. PJM staff will develop material to present at the next PC Meeting to continue the discussion.

## 9. RAAS Update

Mr. Tom Falin provided an update on RAAS Activities. The RAAS discussed the impact of modeling DR in RRS, the load model selection, and world modeling (Capacity Benefit of Ties). The next RAAS meeting will be held on February 23, 2016 to continue to discuss the study assumptions with the intent to bring a recommendation to the PC in April or May. <u>RAAS website</u>

### 10. Capacity Performance Update

Mr. Falin facilitated a discussion of CIR determinations and Capacity Factors of Intermittent Resources. The current rules for Capacity Injection Rights, Summer Capacity Verification Tests were discussed. Potential updates to the wind and solar class average reporting and calculation were discussed, items were presented to show differences in determining wind and solar capacity factors based on the median values as opposed to the average values. The handling of UCAP determinations for Run of River Hydro and Landfill Gas units under the Capacity Performance construct was also discussed. PJM staff will conduct further analysis to present at the next PC meeting to continue the discussion of UCAP and CIR Determinations of Intermittent Resources.

# 11. Local Planning Update

Mr. Paul McGlynn provided an update on Local Planning. An overview of prior discussions of Local Planning in relation to FERC Order 1000, FERC Docket ER15-1344, and Subregional RTEP Committee meetings was provided. Mr. McGlynn noted a draft problem statement was reviewed at the January 28, 2016 MRC Meeting regarding developing PJM Criteria/Guidelines for Assessing End of Life Transmission Facilities.



## 12. MISO Queue Reform

Mr. Berner presented an update on the MISO Queue Reform. As part of the reform, MISO is splitting their process into 3 phases, as opposed to 2 phases. The proposed queue reform does not align with PJM's calendar for studies and provisions in the process to delay final phase studies for certain conditions may cause schedule shifts. Members are encouraged to attend the MISO/PJM JCM stakeholder meeting on February 18, 2016.

#### Model On Demand Update

Review of Model on Demand data submittals by TOs is well under way. Upon completion of the data submittals, preliminary cases for the 2016 series of MMWG cases will be put together for base case years 1, 2, 5, and 10 and TOs will be asked to review these cases.
