

# DER Ride Through Task Force (DERRTTF) Final Report

Date (November 12, 2019)

### **Issue Creation**

Problem Statement (<u>link</u>) and Issue Charge (<u>link</u>) brought forward by PJM and approved at the November 8, 2018 Planning Committee.

## Issue Summary

IEEE recently approved changes to the IEEE 1547-2018 standard to improve the response of distributed energy resources after a transmission system fault. The Task Force was charged with reviewing the technical information surrounding these changes and develop a recommendation that will allow DER resources to meet the IEEE standard and maintain PJM system reliability.

#### 1. Recommended Proposal

Stakeholders expressed interest in a technical recommendation from PJM that can be used by DER facilities in absence of local standards from the distribution or transmission companies. The PJM recommendations were confirmed against an analysis of the New Jersey transmission and distribution system with a large penetration of DER resources.

The Task Force created a recommendation paper that will be posted on PJM's website and referenced in PJM Manual 14D.
