

PJM Retiring Use of Weak Encryption

PJM requests that each company update the encryption on the source devices to use an acceptable level of encryption documented in <u>https://www.pjm.com/-</u> / <u>/media/etools/security/weak-encryption-remediation-guide.ashx</u> .	Production 02/28/2022 6 to 8 pm	Voting Application Users - Voters will not be able to access the voting application (and will not be able to vote) without following the updated procedures provided.
There is no impact if the company updates the encryption prior to Production deadline.

Transport Layer Security (TLS) securely transfers data between clients and servers. TLS is used to secure data on websites (commonly known as HTTPS).

PJM has determined that using older versions of TLS present a security vulnerability.

TLS 1.0 and TLS 1.1 versions are no longer secure.

 Interception/decryption of secured data is possible when depreciated versions are in use. PJM will stop supporting TLS 1.0 and TLS 1.1 and will continue supporting only TLS 1.2 in production applications.

- Support for TLS 1.0 and TLS 1.1 will stop on Feb. 28 for
 Production Voting Application.
- Voting users will not be able to access the application unless browser settings set to TLS 1.2.
- In the future, PJM will also stop supporting TLS 1.0/1.1 for other PJM Tools, and PJM.com and the browser configuration will globally apply to all applications accessed via the same browser.

Next Steps



Voting users can verify their browser configuration by visiting Voting application (votingtrain.pjm.com) in the Train environment.as TLS 1.0 and 1.1 are disabled.

• If a user is prompted with Train SSO login page, their browser is using the correct supported configuration. If the Voting Application user receives a connection error upon visiting votingtrain.pjm.com, their browser has to be configured.

- Personal laptops can be updated by users directly.
- Company help desk engagement might be required for company-issued laptops (due to company restrictions on certain browser settings).

Support for TLS 1.0 and TLS 1.1 will end on Feb. 28 for Production Voting Application.

 A test vote will be issued on March 1 to ensure all Voting application users are able to access the Production Voting Application.

These steps must be taken by Feb. 28, 2022 by all Voting Application users to retain ability to vote
