

- Single Sign On (SSO) System upgrades
 - When:
 - Train: Completed
 - Production: September 7
- Impacts
 - SSO Token length is changing with upgrade and not going to be a fixed value
 - Any code parsing SSO Authentication response based on length will need to change. Use JSON parser or other methods
