Administration

1. Increment Offer (INC) and Decrement Bid (DEC) Credit Requirement

Hal Loomis, PJM, informed the Subcommittee that the proponent of the INC and DEC Credit Requirements Problem Statement and INC/DEC Issue Charge is leaving the membership, and indicated that PJM will ask the Subcommittee at the next August meeting whether it would like to either close out the issue or continue to pursue it.

Mr. Loomis presented education on solution option A. The CS requested historical back testing and credit requirement impact analysis. Mr. Loomis indicated that back testing is not possible without recreating RTEP runs, but said that PJM is working on an analysis of two major upgrades to show the accuracy of the proposed solution.
