



DER and Inverter-based Resources Subcommittee WebEx Only February 3, 2021 9:00 a.m. – 4:00 p.m. ET

Administration (9:00 – 9:15)

- 1. Scott Baker opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from the January DIRS meeting and the EDC coordination workshop were approved with 0 objections and 0 abstentions.
- 3. Scott Baker reviewed the DIRS work plan.
 - Scott briefly reviewed the DIRS work plan highlighting that stakeholders are in the packaging
 phase of the solar-battery hybrid resource issue and hope to advance a proposal to the MIC in the
 next meeting or two.
 - Scott also discussed DER aggregation/order 2222 compliance schedule highlighting that PJM would start discussing the straw proposal starting in March.

Order 2222 – EDC Coordination Workshop (9:15 – 11:15)

- 4. PJM staff led a discussion on the Utility Review Process, specifically the DER and DER Aggregation registration process.
 - Pete Langbein, PJM, discussed, on a high level, a proposed DER process. Pete also reviewed the status quo and additional requirements for registration process for EDC data verification and visibility. Later, Pete also discussed a proposed EDC registration review timeline.
 - Pete presented current EDC data approval in DR Hub highlighting several key features within the app, such as market eligibility and max capacity market participation.
 - Pete discussed the status quo and additional requirements for settlements/compliance process for EDC data verification and visibility. Pete also highlighted the EDC data verification and visibility in the DR Hub.
 - Andrea Yeaton, PJM, reviewed additional EDC coordination based on order 2222 and reiterated RERRA restrictions.

Order 2222 – Discussion on compliance directives (11:30 – 2:15)

5. PJM staff continued discussion around potential policies related to the interconnection and market participation requirements of DER and DER aggregations.





- Danielle Croop, PJM, put forth initial thoughts around compliance directives for FERC order no.
 2222 such as market participation and interconnection and opened the discussion for stakeholder feedback.
- 6. Betty Watson from Modern Energy and on behalf of the Advanced Energy Management Alliance presented proposed market participation concepts for DER Aggregation.
 - Betty highlighted several key provisions from FERC order no. 2222 and reviewed straw DER participation model.
 - Betty discussed key topics such as energy market, energy settlement, cost justification, ancillary services, capacity, Capacity Injections Rights, double counting/dual participation, charging energy for energy storage, distinction between metering and telemetry, metering options, baseline methodology, data and telemetry, focus on quality of data, locational requirements and minimum aggregation size.
- 7. Thomas DeVita discussed PJM compliance filing deadline and sought stakeholder feedback on requesting a deadline extension from FERC.
 - Thomas reviewed the current timeline for PJM's compliance filing for FERC order no. 2222.
 - Thomas reviewed several key points for considering a 3-6 month extension for the filing. Thomas also highlighted that currently, there is no specific implementation timeline, but PJM staff remarked that its current thinking is sometime in 2023 given existing projects and priorities.

Solar-Battery Hybrid Resources (2:15 – 3:45)

- Thomas DeVita reviewed a recent FERC Order requiring PJM to submit an information report about the status of various issues related to hybrid resources (AD20-9-000). The informational report is due July 19, 2021.
 - Thomas highlighted that the short order directs PJM to submit a report regarding four hybrid resources areas. The four areas are terminology, interconnection, market participation and capacity valuation. Thomas also highlighted that PJM must submit its report within 180 days, providing a description of its current practices related to each of these four issues, an update on the status of any ongoing efforts to develop reforms related to each of the four issues and responses to the specific requests for information contained within the order.
- 9. Andrew Levitt finished reviewing all items in the hybrid solutions matrix, noting a few changes to solution options.
 - Andrew indicated a potential solution for the dispatchable solar-battery hybrids under design component; operating requirements.
 - Andrew discussed design components and packages and took several suggestions from stakeholders.
