- 1. Scott Baker, chair, opened the meeting and reviewed the agenda.
- 2. Chris Callaghan, secretary, reviewed the meeting participation guidelines and minutes from the last meeting.
- 3. Scott Baker reviewed updates to the DIRS work plan, notably the updated work plan for the Hybrids Phase II effort.

#### **Hybrid Resources (9:15 – 10:05)**

- 4. Andrew Levitt, PJM, provided an update on the re-filing of the Hybrids Phase I FERC filing (ER22-1420), noting that the expected implementation date of the Phase 1a proposal (mostly Tariff definitions) is now July 13, 2022.
- 5. Andrew Levitt, PJM, presented a market participation example for solar-battery mixed technology facilities, including market participation options for both co-located and hybrid market models.
- 6. Andrew Levitt, PJM, provided a courtesy review of draft business manual language associated with the Hybrids Phase I filing. Draft language for manuals affected manuals will be reviewed with the subcommittee prior to their first read at the appropriate standing committees (MIC, OC).
- 7. Andrew Levitt, PJM, reviewed solution options in the Hybrids Phase II matrix.
  - a. PJM requested comments, questions, and/or alternative suggestions for the June 20, 2022 meeting.

#### Order 2222 (10:05 - 12:15)

- 8. Thomas DeVita and Danielle Croop, PJM, addressed the request for information issued by FERC in response to PJM's Order 2222 filing and solicit stakeholder feedback.
  - a. PJM will notify the DIRS email distribution group regarding updates on PJM's extension request. This extension would move the PJM response due date to July 7th.
  - b. PJM requested stakeholder input on the RFI questions by June 14, 2022.
  - c. The posted material was reposted with minor edits/additions.
- 9. Joint Utilities provided material for discussion regarding the Component DER Pre-Registration & DER Aggregation Registration, and provide an overview of the utility DER Aggregation study process.
