	Background:		
	The technical specifications for, and testing of, the interconnection and interoperability between utility power systems and distributed energy resources (DERs) are the focus of this IEEE standard.		
	This guideline provides high-level guidance and perspectives that should be considered during the adoption and implementation of the IEEE standard.		
	Specifically, the guideline focuses on issues pertaining to DER that have been identified by SPIDERWG as potentially having an impact to the BPS.
