Maria Baptiste provided an update on the latest and upcoming eDART release. eDART is on track to retire Legacy Browserless in Production in Q4. eDART Account Migration to Account Manager Project has begun and will be open to 12/13/2023. PKI Certificates are now required for all browserless communications and there is a new PJM CLI jar file. SUMA will not be enabled for eDART in Account Manager but CDW functionality is available. Future release includes enhancements to TERM application in response to FERC Order 881.
