 Kevin Hatch provided an update of System Operations in November. PJM and its members experienced 1 Shared Reserve Event, 2 Synchronized Reserve Events, 22 PCLLRW Events, 5 Non-Market PCLLRW Event, 2 High System Voltage Events, and 1 Geomagnetic Disturbance Warning Event.

Tools (9:20-9:25)

- Chidi Ofoegbu provided an update on the latest and upcoming eDART release. eDART Browserless refresh is completed in eDART and the legacy browserless feature has been retired in production on November 1st, 2023.
 - The eDART Account Migration to Account Manager is underway until December 13th, 2023. PKI Certificates are now required for all browserless communications and there is a new PJM CLI jar file.
 - b. SUMA will not be enabled for eDART in Account Manager but Company Distributed Workflow (CDW) functionality may be able to reduce need for multiple accounts.
 - c. There is a future maintenance release in production on 12/20/2024 (tentatively) which includes enhancements to TERM application in response to FERC Order 881.
