- 3. OPSI 2016 Budget Mr. Carmean was available for questions regarding the preliminary 2016 OPSI budget. PJM members have the ability to provide feedback to OPSI through the end of August 2015 on the 2016 OPSI budget.
- 4. Monitoring Analytics Preliminary 2016 Budget Dr. Bowring presented the preliminary 2016 budget for Monitoring Analytics. He reviewed the projected 2016 operating expenses by financial category, projected 2016 revenues net of expenses, 2016 capital expenditures and cash flow.
- 5. 2015 PJM Financial Statement Review Ms. Drauschak reviewed highlights from PJM's unaudited financial statements as of and for the six months ended June 30, 2015.
- 6. First Quarter Financial Review Mr. Snow reviewed the operating expenses, service category charges, and capital spending for the guarter ended June 30, 2015.
- 7. 2015 Forecast Mr. Snow presented the PJM forecasted operating expense and capital expenditures for 2015.
- 8. Preliminary 2016 PJM Budget Mr. Snow presented preliminary 2016 expense and capital budgets by major category, projected 2016 Schedule 9 revenues, expense cost trends by major category from 2008 through 2016, capital expenditures from 2001 through 2016, and preliminary 9-MMU and FERC Fee rates for 2016.
- 9. 2015 2019 Financial Projections Mr. Snow presented the preliminary financial projections for revenues, expenses, deferred regulatory liability balances and refunds from 2015 through 2019.
