Introduction

Questions regarding the availability of information on methodologies for calculating total hourly energy obligations (“THEO”), peak load contributions (“PLC”), and network service peak loads (“NSPL”) were raised by certain members of the PJM Markets & Reliability Committee. The sections of the PJM tariff containing this referenced information for some of the PJM Transmission Owners are those sections that are in the exclusive jurisdiction of the PJM Transmission Owners. Accordingly, the TOA-AC formed a working group to review the questions, gather information, and report back to the TOA-AC with any recommendations, as appropriate. The TOA-AC also agreed that the working group meetings should be open meetings (in accordance with Section 8.4.4 of the Consolidated Transmission Owners Agreement) so that all PJM members can participate.

Purpose

The TOA-AC THEO, PLC and NSPL Working Group will review the questions regarding the availability of the THEO, PLC, and NSPL methodologies, gather information, and report back to the TOA-AC with any recommendations, as appropriate.

Tasks

The primary tasks of the Working Group are to:

- Review the availability of the methodologies for calculating THEO, PLC, and NSPL;
- Address questions regarding the availability of the methodologies raised by stakeholders;
- Deliberate on issues raised during the stakeholder process and make recommendations to the TOA-AC, as appropriate.
