# 2. REVIEW OF PROCESS INCLUDING KEY TASKS AND DEADLINES FOR DR PARTICIPATION IN UPCOMING 2017/18 BRA (9:45 – 10:00)

PJM will review key tasks and deadlines for the upcoming BRA including the recently approved FERC Order that limits the amount of Limited DR.

## 3. PEAK LOAD CONTRIBUTION REVIEW (ASSIGNED BY CSTF) (10:00 – 10:25)

Issue 1: PLC Risk: PJM will present Manual changes for the proposed solution that would allow CSP to claim additional MW as "existing" through an exception process if the nominated amount of the registration is low due to anomaly that resulted in a low PLC for the upcoming delivery year.

Issue 2: PLC Alternative: It is proposed that this item will no longer be pursued based on stakeholder priorities, interests and discussions to date.
