**Administration:**

1. Roll was called.
2. There were no changes to the 01/21/2015 meeting minutes.
3. There were no additional agenda items.
4. Brief update/discussion of DR related activity in other stakeholder groups:
  - A. MRC – Residential M&V was approved, however PJM plans to discuss at the next MRC (2/26/2015) a plan to delay the filing until the May/June timeframe, which would push the implementation and transition years out another year. Stakeholders are encouraged to participate in the discussion at the MRC.
  - B. MRC – the procedural process and timeline for the Stop Gap Filing will be discussed at the next MRC (2/26/2015). The DRS is discussing more of the implementation issues, however stakeholders are encouraged to learn about timelines and process at the MRC.

**Meeting Center Pilot**

Ms. Tawnya Luna, PJM, presented upcoming changes to how stakeholder meetings on [pjm.com](http://pjm.com) are presented to members and scheduled. The DRS will pilot the changes starting with the 4/22/2015 meeting. The main Committee page will be streamlined to display the next five meetings and the last 15 meeting details. All detail will still be available by clicking a link. To schedule a meeting, a new button will take the user the new Meeting Center which can be customized by the user and features a checkout process to schedule meeting attendance. Stakeholders and users are encouraged to give feedback to PJM on the new user experience.

**Review Changes to DR Regulation (Manual 12)**

Ms. Danielle Martini, PJM, reviewed Manual 12 clarification changes to the Demand Response regulation testing section which are up for endorsement at the next OC and MIC. The current process is not being changed, just clarified in M12.

**eLRS Data Archive**

Mr. Glenn Long, PJM, presented a plan to archive data from current eLRS production system starting April 15, 2015.. All data related to any registrations terminated 2 ½ years ago will be removed from eLRS. However, any location data (including meter data) will not be removed until all registrations related to the location have been terminated for 2 ½ years. PJM maintains a complete backup of all data for seven years. Stakeholders are encouraged to pass this information to their eLRS users so that they are aware of the archive plan and any historical data may be downloaded prior to the archive

### AUDIT FOR 30-MINUTE LEAD TIME EXCEPTIONS

Ms. Andrea Yeaton, PJM reviewed the audit process for the 30 Minute Lead Time Exception process. Beginning April 15th, PJM will contact CSPs with a list of registrations being audited. The CSPs have 3 business days to forward supporting documentation to PJM, and PJM has 10 business days to make a decision.

### DR STOP GAP FILING

Mr. Pete Langbein, PJM, led a discussion of some of the implementation issues with DR Stop Gap (which may only go into effect if Supreme Court reject cert for EPSA case). Key points discussed: 1) clarification that the LSE (or LSE Agent) registering resources to meet their RPM commitment must be serving the load of the resource, meaning it may not be another LSE's load, 2) if an LSE transfers a WLR commitment to another LSE, that transfer is completely voluntary, unless a RERRA arrangement states otherwise 3) the changes to M&V with respect to GLD and non-summer compliance, and 4) LSEs (or LSE Agents) must be able to terminate and add new registrations during the Delivery Year. Parking Lot topics identified are: the role of EDCs (especially for Muni or Co-op) in the auction and registration process, the rules for Existing vs. Planned WLR and what happens when an LSE with WLR commitment goes bankrupt.
