Consolidate all defined terms in one governing document

 Eliminate possibility of multiple or conflicting definitions of the same defined term in different agreements

 Eliminate "definitions" that are simply cross references to how a term is defined in another document. Example: "Annual Demand Resource" shall have the meaning specified in the Reliability Assurance Agreement."



Consolidate terms that mean the same thing into one definition.
 Example: Operating Agreement, Operating Agreement of the PJM Interconnection, L.L.C and PJM Operating Agreement.

 Other conforming revisions in governing documents to change references that indicate a term being defined "in this Agreement" to change it to say it is defined "in the Tariff"





- 26 defined terms are not consistent across governing agreements
- Some inconsistencies are minor, stylistic differences while others are more substantive

- PJM counsel and SMEs reviewing inconsistent defined terms to determine:
 - -the correct definition of those terms
 - -whether more than one definition is truly needed and if create another term to use for one so we aren't using same defined term to mean different things in different agreements
 - -PJM will bring through the GDECS for discussion



TOs have FPA, section 205 rights over CTOA

 Consolidation proposal will be raised with TOs at their December 2016 TOAC meeting

 If TOs do not want to consolidate the CTOA defined terms, proposal will only include consolidating the defined terms from the Tariff, OA and RAA



- PJM preference is to move all defined terms to Tariff rather than a new, stand alone governing document
 - vast majority of defined terms are in Tariff (see slide 2)
- To extent term is now only substantively defined in RAA, OA or CTOA, move that definition to the Tariff
- To address Member concerns about retaining FPA, section 205
 rights to defined terms in OA, suggest there be two definition sections
 in the Tariff one for which PJM has sole section 205 rights and one
 for which PJM shares section 205 rights with Members



 In definitions section of the OA, RAA and CTOA, incorporate general language that states something similar to the following:

"Unless the context otherwise specifies or requires, all capitalized terms used in this Agreement shall have the respective meanings assigned in the PJM Tariff for all purposes of this Agreement (such definitions to be equally applicable to both the singular and the plural forms of the terms defined). Unless otherwise specified, all references herein to sections, Schedules, Exhibits or Appendices are to sections, Schedules, Exhibits or Appendices of this Agreement."

- MRC first read February 2017
- MRC vote March 2017

- Filing April or May 2017
- Don't need long discussion since few, if any, substantive revisions to definitions
