### 3. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Ray Fernandez, PJM, discussed the proposed high level Power Meter changes related to the Sub-Hourly Settlements implementation and provided an update on the FERC request for additional information on the PJM compliance filing. PJM will be filing a response to the request for additional information on March 27, 2017.

There was a request for additional discussion on potentially allowing manual edit capabilities for five-minute data in Power Meter.
