Mr. Falin opened the meeting and reviewed the agenda. Mr. Scarpignato requested that PJM look further into Winter LOLE studies in light of recent winter resource adequacy issues. PJM will discuss the matter internally and report back to the RAAS at a future meeting.

PJM Website Update

2015 RRS Load Model Assessment

Mr. Rocha presented detailed results of analysis performed by PJM staff regarding the selection of a load model time period for both PJM and the World regions. The analysis focused on the 2019/2020 Delivery Year and followed the procedure approved by the Planning Committee at its July, 2009 meeting.

PJM recommended a 10 year load model based on the years 2003-2012 for use in the 2015 RRS Base Case. Following discussion, the RAAS unanimously approved the 2003-2012 load model for use in the 2015 RRS Base Case.
