# 1. ADMINISTRATION

Ms. Ford called the meeting to order and Ms. Egan took attendance. Minutes from the August 08 meeting were approved.

Ms. Ford reminded the group that the August 22 CSTF meeting has been cancelled to accommodate other stakeholder meetings.

#### 2. DR CAPACITY MARKET TRANSITION MECHANISM FOR NEW 30 MINUTE LEAD TIME

Mr. Pete Langbein, PJM, reviewed the proposed timeline for voting by CSTF participants on the <u>transition</u> <u>mechanism</u>. He proposed that the vote would open to the TF on 9/3 and close at 5 pm on 9/8. It was decided that results would be reviewed at the 9/12 meeting. This item was already taken to the MRC for a first read in August and will go to the MRC for endorsement on 9/18.

#### 3. POLL RESULTS AND NEXT STEPS

Ms. Ford reviewed the <u>results</u> of the poll taken by the task force participants on the solution packages and specific design components, as they relate to the Triennial Review. She then discussed next steps with the task force which included a vote to be conducted opening on 8/15 and closing at 5 pm on 8/19. The results of the vote were included in the 8/21 MRC meeting material.



# 4. SOLUTION PACKAGE REVIEW AND CONSENSUS BUILDING

Based on the results of the poll conducted between 8/15 and 8/19, prior to the CSTF vote on the available packages, Ms. Ford led the TF in a discussion around winnowing down the packages. Based on this conversation, it was determined that all <u>packages</u> would be included in the CSTF vote.
