First was whether to consider if CP-capable resources that cleared as Base could offer to upgrade their obligation to CP to replace non-viable CP commitments made by others prior to the 3rd IA. The second suggestion was to include consideration of the process participants follow to submit buy bids in the Incremental Auction. A poll will be sent to the members of the Senior Task Force to determine if these additional topics should be considered in scope.

4. Mr. John Hyatt and Ms. Alexandra Salanek, Monitoring Analytics, provided stakeholders with a summary of recent Incremental Auction practices and statistics.
