5. Monitoring Analytics (MA) 2016 Financial Statements – Dr. Bowring answered questions on the MA audited financial statements of 2016.
6. First Quarter 2017 PJM Financial Statement Review – Ms. Daugherty reviewed highlights from PJM's unaudited financial statements as of and for the three months ended March 31, 2017.

In response to an inquiry, Ms. Daugherty reported what PJM has heard about a potential new Pennsylvania tax on virtual transactions undertaken in the PJM energy markets. She indicated that PJM has been communicating with PA Senate staff and the PA Department of Revenue about the potential jurisdictional, financial and market impacts of such a potential tax.
