#### Administration

Ms. Daugherty and Mr. Anders welcomed the participants, and provided the announcements and antitrust and code of conduct announcements. Mr. Chad Hutchinson discussed implementation of the new PJM Now mobile application.

#### Endorsements/Approvals

#### 1. Draft Minutes

Minutes of the November 17, 2016 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections or abstentions.

#### 2. PJM Manuals

- A. Mr. Augustine Caven reviewed proposed revisions to Manual 10: Pre-Scheduling Operations regarding the periodic review of the manual, end of outage reporting and the 72-hour maintenance outage recall process.
- B. Mr. Chris Pilong reviewed proposed changes to Manual 13: Emergency Operations.
- C. Mr. Augustine Caven reviewed proposed revisions to Manual 14D: Generator Operational Requirements regarding fuel limitation reporting.

Following discussion, the committee **endorsed** the proposed revisions in items 2.A through 2.C by acclamation with no objections and one abstention to item 2.A.

#### 3. Replacement of Capacity Obligations

Mr. Stu Bresler and Dr. Joe Bowring presented proposed revisions to Manual 18: Capacity Market regarding the immediate replacement of capacity obligations. Mr. Mike Cocco proposed a friendly amendment to add the following sentence at the end of the bullet immediately preceding the list of four acceptable reasons for replacement:

"PJM will approve or deny a request for early Replacement Capacity, based upon the below criteria, with input from the Market Monitor, within 15 days of receiving a completed early Replacement Capacity request."

This proposed amendment was accepted as friendly by Mr. Bresler and Dr. Bowring. Following discussion, the committee **endorsed** the proposed revisions in a sector-weighted vote with 4.39 in favor.





#### 4. Residual ARR Enhancements

Mr. Brian Chmielewski presented the proposed solution to the Residual ARR Enhancements issue. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.

#### 5. FTR Undiversified Credit Adder

Mr. Hal Loomis presented proposed revisions to the FTR undiversified credit adder. Following discussion, the committee the proposed revisions **failed** in a sector-weighted vote with 1.25 in favor.

#### First Readings

#### 6. PJM Capacity Problem Statement / Issue Charge

Mr. Ed Tatum, American Municipal Power, presented an updated problem statement / issue charge regarding PJM Capacity. The committee will be asked to approve the proposed problem statement / issue charge at its next meeting.

#### 7. <u>Underperformance Risk Management Sr. Task Force (URMSTF)</u>

Ms. Rebecca Carroll presented a proposal regarding participation as Capacity Performance by resources external to PJM's footprint. The committee will be asked to endorse these proposed revisions at its next meeting. Ms. Carroll also noted that the Members Committee will be asked to endorse the proposal at its next meeting.

#### 8. Energy Market Uplift Senior Task Force (EMUSTF)

Mr. Dave Anders discussed the activities of the EMUSTF, and presented two Phase 1 proposals endorsed by the EMUSTF and offered to the MRC as a main and alternate motion. The committee will be asked to endorse the Phase 1 proposal at its next meeting. Mr. Anders discussed the results of voting on Phase 2 proposals, indicating that no proposals received the required simple majority support required for automatic advancement to the MRC. Mr. John Horstmann moved and Mr. Jim Benchek seconded that:

- the EMUSTF be asked to take a second vote on the top five proposals in terms of the support received in the prior EMUSTF vote (i.e. packages Q, D, U, S and T),
- that the vote results be posted timely for the MRC's next meeting,
- that the MRC be asked to vote on proposals that receive the required support at the EMUSTF (i.e., rank ordered proposals that receive a minimum of simple majority support), and
- that PJM make "best efforts" to perform (and/or summarize previously performed) back-testing
  on the five proposals (packages Q, D, U, S and T) to support the voting schedule.





Following discussion the motion was <u>approved</u> by acclamation with three objections and no abstentions.

#### 9. Market Operations Price Transparency

Mr. Rami Dirani presented a proposed problem statement / issue charge regarding Market Operations Price Transparency. The committee will be asked to approve the proposed problem statement / issue charge at its next meeting.

#### 10. Operating Parameters

Mr. Tom Hauske reviewed proposed revisions to the PJM Tariff, and Manual 11: Energy & Ancillary Services Market Operations, Manual 12: Balancing Operations, and Manual 28: Operating Agreement Accounting regarding Operating Parameters. The committee will be asked to endorse these governing document revisions at its next meeting.

#### 11. Governing Documents Enhancement & Clarification Subcommittee (GDECS)

Ms. Janell Fabiano presented proposed Tariff, Operating Agreement (OA) and Reliability Assurance Agreement revisions regarding clean-up of definitions. The Committee will be asked to endorse these proposed revisions at its next meeting.

#### 12. PJM Manuals

- A. Mr. Eric Hsia presented revisions to Manual 11: Energy & Ancillary Services Market Operations and Manual 12: Balancing Operations to account for the updated Regulation Requirement developed by the Regulation Market Senior Issues Task Force. The committee will be asked to endorse the proposed revisions at its next meeting.
- B. Mr. Ray Fernandez presented revisions to Manual 27: Open Access Transmission Tariff Accounting as part of an annual review process. The committee will be asked to endorse the proposed revisions at its next meeting.
- C. Mr. Liem Hoang presented proposed revisions to Manual 38: Operations Planning. The committee will be asked to endorse the proposed revisions at its next meeting.
- Ms. Kim Sauerwine presented proposed revisions to Manual 40: Training and Certification
   Requirements. The committee will be asked to endorse the proposed revisions at its next meeting.

#### Informational Updates

#### 13. Extended Winter Transmission Outage

Ms. Nancy Huang discussed extended transmission outages for the 2016/17 winter.

#### 14. Joint Operating Agreement (JOA) Revisions

Mr. Phil D'Antonio provided a status update on JOA revisions related to the new operating protocols for the PJM/NYISO interface. PJM confirmed that these revisions are not intended to supersede or modify





any rights or responsibilities afforded to the Transmission Owners under the Consolidated Transmission Owners' Agreement.

#### 15. Fuel Cost Policy

Mr. Tom Hauske provided an update on proposed revisions to Manual 15: Cost Development Guidelines regarding Fuel Cost Policies. The committee will be asked to endorse these proposed revisions upon FERC approval of the related compliance filing.
