Administration

- 1. Ms. Bhavana Keshavamurthy and Ms. Chantal Hendrzak provided announcements; reviewed the Antitrust, Code of Conduct, and Public Meetings/Media Participation guidelines, the WebEx Participant Identification Requirement, and Issue Tracking.
 - Mr. Ray Fernandez, PJM, provided an update on the settlements impacts of FERC EL05-121-009.
- 2. The Committee **approved** the draft minutes from the June 6, 2018 MIC meeting by acclamation with 0 objections and 0 abstentions.

Endorsements/Approvals

3. Governing Document Revisions for Seasonal Demand Response Registration
Ms. Andrea Yeaton, PJM, and Ms. Terri Esterly, PJM, reviewed revisions to Manual 18: PJM Capacity
Market, the Open Access Transmission Tariff (OATT) and the Reliability Assurance Agreement (RAA)
associated with the registration process for aggregated seasonal Demand Response resources.

The Committee endorsed the Manual 18, OATT and RAA revisions by acclamation with 0 objections and 0 abstentions.

4. FTR Credit Proposal

Ms. Bridgid Cummings, PJM, reviewed two FTR Credit proposals developed at the Credit Subcommittee (CS), and the associated OATT revisions. Mr. Bruce Bleiweis, DC Energy proposed a friendly amendment to PJM package A, but PJM did not consider the amendment friendly. Mr. Bleiweis made a motion to consider the amendment as Package C, and the motion was seconded by Mr. Bob O'Connell, PPGI. The Committee voted on all three packages.

The Committee endorsed Package A (PJM) with 208 (95%) in favor, 12 (5%) opposed, and 21 abstentions.

The Committee did not endorse Package B (PJM) with 77 (35%) in favor, 141 (65%) opposed and 15 abstentions.

The Committee did not endorse Package C (DC Energy) with 51 (44%) in favor, 66 (56%) opposed and 119 abstentions.

The committee also preferred Package A over status quo with 193 (92%) in favor, 16 (8%) opposed, and 11 abstentions. Package A will move as the main motion to the July MRC.
