## Administration

Mr. Steve Lieberman welcomed stakeholders. He noted that item G had been added to the Consent Agenda. There were no objections to this amendment to the agenda.

## Endorsements/Approvals

### 1. Members Committee Resolution

Ms. Sharon Segner, LS Power, presented a resolution related to PJM Transmission Owners' Section 205 consultation with the PJM Members Committee under Section 9.1 of PJM OATT. Ms. Segner moved and Mr. Erik Heinle, DC Office of the Peoples' Counsel, seconded that the committee approve the presented resolution. Ms. Segner and Mr. Heinle amended the resolution to remove the following phrase: ", nor addressed the impacts to operating or developing generation assets" from the fifth introductory clause.

Ms. Mandy Meadors, Duke Energy Business Services LLC, raised a point of order seeking a determination of whether the motion was properly in order, since Ms. Segner indicated LS Power's intent to cite the resolution (if approved by the Members Committee) in a future FERC filing. Mr. Lieberman determined that the motion was in order, as there is no related prohibition in PJM's governing documents. Mr. Alex Stern, PSEG, moved and Mr. Kevin Kilgallen, Avangrid Renewables, LLC, seconded a motion to appeal the decision of the Chair. Following discussion, the motion to appeal the decision of the Chair failed in a sector-weighted vote with 1.43 in favor.

The motion to approve the resolution was approved in a sector-weighted vote with 3.83 in favor.
