- Dominion discussed a new solution package option and Sharon Thomas provided feedback on the proposals on behalf of the Energy Storage Association.

• Stakeholders are finalizing proposals and are the final stages of narrowing packages and are gearing up to test for support, and if feasible, recommend a tier 1 (preferred) or tier 2 solution to the MIC and OC in July. If not feasible, then proposal(s) will be taken to the MIC and OC in August for a first read.
