Administration

Nicholas DiSciullo reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the July 14, 2021 Market Implementation Committee meeting with **0 objections and 0 abstentions**.

Endorsements/Approvals

2. Manual 11 Revisions – 5-Minute Dispatch and Pricing

Aaron Baizman provided an overview of revisions to Manual 11: Energy & Ancillary Services Market Operations. The changes address Five Minute Long Term Changes and Transparency. The committee endorsed the Manual 11 Revisions addressing Five Minute Long Term Changes and Transparency by acclamation with 0 objections and 0 abstentions.

3. Manual 11, Manual 18, and Manual 28 Revisions – Fast Start Pricing

- a) Phil D'Antonio provided an overview of revisions to Manual 11: Energy & Ancillary Services Market Operations, Manual 18: PJM Capacity Market, and Manual 28: Operating Agreement Accounting. The changes address the implementation of Fast Start Pricing.
- b) Catherine Tyler provided an overview of IMM concerns with the formation of Ancillary Service Market Clearing Prices under some Fast Start conditions.
- c) Zhenyu Fan and Phil D'Antonio reviewed Fast Start implementation and metrics.

The committee endorsed the Manual 11, Manual 18, Manual 28 revisions for Fast Start Pricing with 228 (94%) in favor, 14 (6%) opposed, and 8 abstentions.

4. Solar-Battery Hybrid Resources

- a) Andrew Levitt provided an overview of Package A that was developed in the DER and Inverter-based Resources Subcommittee (DIRS).
- b) Jim Davis, Dominion Energy, provided an overview of Package C that was developed in the DIRS

The committee endorsed Package A with 235 (99%) in favor, 3 (1%) opposed and 5 abstentions.

A second vote showed stakeholders preferred Package A over status quo with 204 (100%) in favor, 0 (0%) opposed, and 2 abstentions.

The committee did not endorse Package C with 69 (34%) in favor, 135 (66%) opposed and 16 abstentions.

A second vote showed stakeholders did not prefer Package C over status quo with 99 (43%) in favor, 129 (57%) opposed, and 3 abstentions.

5. Energy Efficiency (EE) Addback

- a) Joe Bowring, IMM, reviewed the Problem Statement and Issue Charge addressing the calculation of the EE Addback.
- b) Jeff Bastian provided education on RPM Auction Participation by EE Resources.
- Lisa Morelli facilitated a discussion to review the interests and design components on the EE Addback Matrix. A Post-Meeting version of the matrix has been posted to the meeting materials.

Because this issue is being worked through the Consensus Based Issue Resolution (CBIR) Lite process, the IMM and PJM will be working offline to create a joint proposal. A first read of the proposal will be provided during the next MIC meeting and stakeholders will have opportunity to suggest revisions or provide alternate options and proposals. Stakeholders are encouraged to contact the IMM or PJM if they are interested in being a part of the offline discussions, or if they have additional interests or design components to offer.

The committee approved the Energy Efficiency (EE) Addback Issue Charge by acclamation with 0 objections and 0 abstentions.

First Readings

6. Manual 15 Revisions - Incremental & No Load Energy Offer

- a) Heather Reiter reviewed the Cost Development Subcommittee (CDS) work plan.
- b) Tom Hauske provided a first read of the Manual 15: Cost Development Guidelines revisions that were developed in the CDS. OA and OATT revisions were provided as an informational only update. The committee will be asked to endorse the Manual 15 revisions at its next meeting.

7. Regional Transmission and Energy Scheduling Practices Revisions

Chris Pacella provided a first read of revisions to the Regional Transmission and Energy Scheduling Practices document. The committee will be asked to endorse the revisions at its next meeting.

8. RPM Capacity Transfer Rights

- a) Kevin Zemanek, Buckeye Power, provided a first read of the Buckeye proposal.
- b) Jeff Bastian reviewed the MW quantity of qualified requests by zone to assist participants in evaluating the impact of the Buckeye proposal.
- c) Lisa Morelli facilitated a discussion to gather solution options from the committee and develop packages. The IMM offered an alternate package for the committee's consideration in advance of the meeting. Following discussion, Morelli ruled the package to be beyond the scope of the approved issue charge. The IMM indicated they will consider bringing a separate issue charge

to address their broader concerns with the consistency of the MWs used to allocate capacity costs versus those used to allocate Capacity Transfer Rights.

The committee will be asked to endorse the Buckeye proposal at its next meeting. Issue Tracking: Capacity Transfer Rights in RPM

Working Items

9. Regulation for Virtual Combined Cycles

- a) Michael Olaleye provided education on the causes of virtual combined cycle units not clearing equally in the regulation market, how this issue differs from regulation awards for combined cycles that are modeled differently, and education on prior-used solutions.
- b) Lisa Morelli facilitated a discussion to review the interests and design components on the matrix. The committee will continue working the CBIR process by providing solution options at its next meeting. Stakeholders are encouraged to provide additional interests and design components in advance of the next meeting. A Post-Meeting version of the matrix has been posted to the meeting materials.

10. Undefined Regulation Mileage Ratio Calculation

- a) Michael Olaleye provided education on the Undefined Regulation Mileage Ratio Calculation issue.
- b) Joe Bowring, IMM, provided education on the Undefined Regulation Mileage Ratio Calculation issue.
- c) Lisa Morelli facilitated a discussion to review the interests, design components, and solution options and solution packages on the matrix. Given the packages reviewed during this discussion were largely consistent with the PJM and IMM solutions presented at prior meetings, Morelli proposed that this meeting be treated as the first read of these packages. No stakeholder objections were voiced.

The committee will be asked to vote on the packages at its next meeting. Issue Tracking: Undefined Regulation Mileage Ratio Calculation

- a) Lauren Strella Wahba reviewed a straw proposal for Real-Time Values.
- b) Keyur Patel discussed options for Parameter Limited Schedules and solicited stakeholder feedback on the tradeoffs of potentially reducing optionality that is currently available in the structure of energy market offers.

Discussions on this issue will continue during the next MIC meeting.
