## 1. July 19, 2021

The PJM team provided education and more details related to their solution proposal. No additional packages were provided.

It was noted that how we transition to a new process is an important part of the overall reform effort. To help address this piece, an additional meeting was scheduled for August 4, 2021 to discuss transition options.

## 2. August 4, 2021

The Amazon team presented some findings from their analysis of the current interconnection queue.

Potential transition options were discussed. A poll focused on determining the amount of support for each transition option was issued the week of August 9, 2021.

## 3. August 23, 2021

The results of the potential transition options poll were reviewed. No definitive preferences were discovered, so time at future meetings will be reserved for discussions around transitioning to a new interconnection process.

Three additional solution packages were provided. Geenex, Clearway and E-Cubed Policies all provided details and answered questions related to their proposals.

The next meeting is scheduled for September 20, 2021. The meeting will be focused on finalizing and searching for possible consensus of the four proposed solution packages. Time will also be allotted to discuss possible transition options.
