Administration

1. Motion Regarding West Virginia PSC Attendance at Liaison Committee Meetings

Jackie Roberts, West Virginia PSC, discussed the desire of the West Virginia PSC to attend meetings of the Liaison Committee with the Board of Managers as observers.

Susan Bruce, Procter & Gamble Paper Products, moved and Greg Poulos, on behalf of the Delaware Division of the Consumer Advocate, seconded the following:

Do Members object to the request of the Public Service Commission of West Virginia (as an ex officio non-voting member of the Standing Committees) to attend the Liaison Committee as an observer?

Ed Tatum, AMP, moved and Alex Stern, PSEG, seconded to appeal the decision of the Chair to accept the motion as written (i.e. written in the negative). Following discussion, the motion to appeal the decision of the Chair **passed** in a sector-weighted vote with 3.28 in favor (N.B., the threshold for a motion to appeal the decision of the chair is simple majority, or 2.50 sector-weighted vote).

Susan Bruce, Procter & Gamble Paper Products, moved and Greg Poulos, on behalf of the Delaware Division of the Consumer Advocate, seconded the following:

Do Members support the request of the Public Service Commission of West Virginia (as an ex officio non-voting member of the Standing Committees) to attend the Liaison Committee as an observer?

Jason Barker, Exelon, moved and David Scarpignato, Calpine, seconded to postpone this motion indefinitely. Alex Stern, PSEG, proposed amending the postponement motion to add a motion to suspend the rules to not publically produce a detailed voting report of the results of the motion to postpone. The mover and seconder accepted the proposed amendment, and therefore it was included in the motion to postpone indefinitely. Following discussion, the motion to postpone indefinitely and to not publically produce a detailed voting report of the results **passed** in a sector-weighted vote with 3.39 in favor.
