1. Administration

Erik Heinle, Members Committee Chair, welcomed stakeholders to the meeting.

- 8. Motions to Amend the Members Committee-Endorsed Interconnection Process Reform Package (11:55-12:45)
 - A. Amber Thomas moved, and Laura Yovanovich, PPL Electric Utilities Corporation d/b/a PPL Utilities seconded a motion to amend the Members Committee-Endorsed Interconnection Process Reform Package related to the Network Upgrade Cost Responsibility Agreement. Following discussion the proposed amendment <u>passed</u> in a sector-weighted vote with 3.712 in favor.
 - **B.** Brian Kauffman moved, and Cyrus Tashakkori, Open Road Renewables, LLC, seconded a motion to amend the Members Committee-Endorsed Interconnection Process Reform Package related to site control for generation interconnection. Following discussion the proposed amendment **failed** in a sector-weighted vote with 1.585 in favor.
 - C. Jim Davis, Virginia Electric & Power Company, will move, and Alex Stern, Public Service Electric and Gas Company, seconded a motion to amend the Members Committee-Endorsed Interconnection Process Reform Package related to site control for projects that include federal or state controlled onshore and offshore lands. Following discussion the proposed amendment <u>passed</u> in a sectorweighted vote with 3.618 in favor.
