## Administration

1. Ms. Christina Stotesbury, PJM, provided announcements and reviewed the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines
2. The committee approved the draft minutes from the June 7, 2017 Market Implementation Committee meeting by acclamation with 0 objections and 0 abstentions.
3. Ms. Christina Stotesbury, PJM, reviewed the active MIC issues on [Issue Tracking](#).  
Mr. Eric Hsia, PJM, provided an update on a Black Start billing adjustment in the AEP zone.  
Ms. Jen Tribulski, PJM, provided an update on the Minimum Offer Price Rule (MOPR) appeal.

## Endorsements/Approvals

4. **Manual Revisions for Capacity Performance & Performance Assessment Hours**  
Ms. Rebecca Stadelmeyer, PJM, reviewed revisions to Manual 11: Energy & Ancillary Services, and Manual 18: PJM Capacity Market, for changes associated with Capacity Performance Shortfall and Bonus MW calculations. **The committee endorsed the manual revisions by acclamation with 0 objections and 0 abstentions.**
5. **Manual Revisions for Intraday Offers**
  - A. Ms. Lisa Morelli, PJM, reviewed proposed conforming revisions to Manual 11: Energy & Ancillary Services, associated with the implementation of Intraday Offers.
  - B. Monitoring Analytics presented additional proposed manual revisions as well as concerns related to the implementation of Intraday Offers in Manual 11.  
After discussion about the manual edits and the concerns offered by the Market Monitor, the vote to endorse Manual 11 revisions for Intraday Offers was postponed. PJM and the Market Monitor will work together to align the revisions, where possible, and present an updated proposed revisions to Manual 11 for endorsement at the August MIC.
6. **Governing Document Revisions to the Limitation on Claims**  
Mr. Steven Shparber, PJM, reviewed Tariff and Operating Agreement revisions related to the Limitation on Claims. **The committee endorsed the governing document revisions by acclamation with 0 objections and 2 abstentions.**

## Working Issues

### 7. Annual Revenue Requirements for new Black Start Units – Phase 2

Mr. Tom Hauske, PJM, presented two solution packages on the Minimum Tank Suction Levels (MTSL) as part of Phase 2 for the Annual Revenue Requirements for new Black Start units. Stakeholders were given an opportunity to offer additional solutions. Discussion around the solutions proposed led to the removal of Package C, leaving only the Market Monitor's package on the table. The Committee agreed to consider this a first read of the single proposal and will seek endorsement for the Phase 2 - Minimum Tank Suction Levels proposal at the August MIC meeting.

### 8. Energy Efficiency Participation in Capacity Markets

Mr. Pete Langbein, PJM, reviewed the Energy Efficiency (EE) problem statement and issue charge that was approved at the June 7 MIC, and proposed working this issue at the Demand Response Subcommittee (DRS) with no objections. Ms. Terri Esterly, PJM, presented education on current EE eligibility and participation requirements. Follow-up education and continued discussion on this topic will take place at the DRS, starting with the July 17 meeting; and regular updates will be provided to the MIC.

### 9. Governing Document Revisions for PJM-MISO CTS

- A. Mr. Michael Olaleye, PJM, presented a first read of conforming revisions to Manual 11: Energy & Ancillary Services, associated with Coordinated Transaction Scheduling. The committee will be asked to endorse the manual revisions at the August MIC meeting.
- B. Mr. Bhushan Dhuri, PJM, presented a first read of revisions to the Regional Transmission and Energy Scheduling Practices document. The committee will be asked to endorse the revisions at the August MIC meeting.

### 10. Transmission Penalty Factors – Problem Statement and Issue Charge

Dr. Joe Bowring, Monitoring Analytics, presented a first read of a problem statement and issue charge associated with Transmission Penalty Factors. The committee will be asked to approve the new issue at the August MIC meeting.

### 11. Market Path/Interface Pricing Point Alignment – Problem Statement and Issue Charge

- A. Dr. Joe Bowring, Monitoring Analytics, presented a first read of a problem statement and issue charge associated with Market Path/Interface Pricing Point Alignment. The committee will be asked to approve the issue at the August MIC meeting.
- B. Mr. John Dadourian, Monitoring Analytics, provided education on interface scheduling and the Pricing Point Alignment issue and reviewed a proposed solution.

Ms. Lisa Morelli, PJM, provided an update on Order 825: Shortage Pricing and PJM's implementation. PJM will continue to update the MIC as PJM investigates shortening the RT SCED look-ahead period from 15 minutes to 10 minutes.
