Administration

1. Ms. Christina Stotesbury and Ms. Chantal Hendrzak, PJM, provided announcements and reviewed the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines.
2. The committee approved the draft minutes from the October 11, 2017 Market Implementation Committee meeting by acclamation with 0 objections and 0 abstentions.
3. Ms. Christina Stotesbury, PJM, and Ms. Chantal Hendrzak, reviewed the active MIC issues on [Issue Tracking](#) and proposed updating issue statuses to address and resolve open issues, and recommended closing a number of issues within the MIC and subcommittees of the MIC.

4. Mr. Foluso Afelumo, PJM, provided a brief update on security changes to the Account Manager tool.

Endorsements/Approvals

5. **Proposed FTR Credit Requirements for Transmission Upgrades**
Mr. Hal Loomis, PJM, reviewed a proposed change in FTR credit requirements to reduce exposure posed by congestion reductions resulting from major transmission upgrades. **The committee endorsed the proposal by acclamation with 1 objection and 0 abstentions.**
6. **Proposed changes to Price Responsive Demand for Capacity Performance requirements**
Mr. Pete Langbein, PJM, reviewed four proposals that came from the Demand Response Subcommittee to update Price Responsive Demand for Capacity Performance requirements. The IMM offered a new proposal and Whisker removed their proposal prior to voting. The committee approved two of the three proposals. **The PJM package was endorsed with 171 in favor (83%), 35 opposed (17%) and 14 abstentions. Package C was endorsed with 116 in favor (62%), 72 opposed (38%) and 21 abstentions. The IMM package was not endorsed with 28 in favor (15%), 164 opposed (85%) and 20 abstentions.**

7. Manual 11, 18, 27, 28, and 29 Revisions for 5-minute Settlements

Mr. Ray Fernandez, PJM, presented revisions to Manuals 11, 18, 27, 28, and 29 associated with the implementation of 5-Minute Settlements. **The committee endorsed the manual revisions by acclamation with 0 objections and 8 abstentions.**

8. Distributed Energy Resources (DER) Charter

Mr. Scott Baker, PJM, provided an update on the Distributed Energy Resource issue that has been worked at Special Sessions of the MIC, and presented two charters to convert the effort to a subcommittee.

The committee approved the amended charter (Item 8B) with 160 in favor (92%), 14 opposed (8%) and 12 abstentions. The original charter failed majority motion with 26 in favor (17%), 130 opposed (83%) and 28 abstentions.

First Readings

9. FTR Modeling, Performance & Surplus

Mr. Brian Chmielewski, PJM, presented a first read of proposals addressing 3 problem statements and issue charges that have been worked in the FTRMPS Special Sessions of the MIC.

- A. Long Term FTR Modeling Enhancements for Future Transmission Expansions
- B. FTR Auction Case Performance
- C. FTR Surplus

The committee will be asked to endorse a proposal for each issue at the December meeting.

10. Seasonal DR Aggregation Registration Rules – Problem Statement and Issue Charge

Mr. Steve Doremus, EnerNOC, presented a first read of a problem statement and issue charge to address the aggregation of summer and winter Demand Response MWs for the Capacity Performance Annual Requirement. The committee will be asked to endorse the problem statement and issue charge at the December meeting.

Mr. John Dadourian, Monitoring Analytics, and Mr. Tim Horger, PJM, reviewed the Market Path/Interface Pricing Point Alignment issue and presented a proposed joint solution. 12. Transmission Penalty Factors

Mr. Devendra Canchi, Monitoring Analytics, reviewed the Transmission Penalty Factors issue and matrix. Stakeholders were given an opportunity to offer interests and design components and are encouraged to send suggested additions to the matrix prior to the December 13 MIC.
