# Administration

1. Ms. Bhavana Keshavamurthy and Ms. Chantal Hendrzak provided announcements; reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation, the WebEx Participant Identification Requirement, and <u>Issue Tracking</u>.

The Committee approved the draft minutes from the July 11, 2018 MIC meeting by acclamation with 0 objections and 0 abstentions.

- A. Ms. Suzanne Daugherty, PJM, provided an update on FTR Default, Credit Policy Enhancements and Liquidation Process.
- B. Mr. Adam Keech, PJM, provided an update on an issue causing regulation market clearing price spikes. PJM will bring a problem statement/issue charge to the next MIC meeting to address this issue.

#### Endorsements/Approvals

# 2. Market Seller Offer Cap Balancing Ratio Proposal

- A. Mr. Pat Bruno, PJM, presented Proposal A.
- B. Mr. Pat Bruno, PJM, presented Proposal B and stated that PJM was withdrawing support of this package. Mr. Dave Mabry, on behalf of the PJM Industrial Customer Coalition, agreed to sponsor this package.
- C. Ms. Sharon Midgley, Exelon, presented the Exelon proposal.
- D. Mr. David Scarpignato, Calpine, withdrew the Calpine proposal.
- E. Joe Bowring, Monitoring Analytics, presented the IMM proposal.

The committee voted on 4 packages.

The Committee endorsed Package A (PJM) with 207 (88%) in favor, 28 (12%) opposed, and 20 abstentions.

The Committee did not endorse Package B (PJM Industrial Customer Coalition) with 20 (9%) in favor, 200 (91%) opposed and 25 abstentions.

The Committee did not endorse Package D (IMM) with 5 (2%) in favor, 195 (98%) opposed and 34 abstentions.

The Committee did not endorse Package E (Exelon) with 71 (36%) in favor, 125 (64%) opposed and 50 abstentions.

The committee also preferred Package A over status quo with 112 (69%) in favor, 50 (31%) opposed, and 57 abstentions.

Package A will move as the main motion to the August MRC. <u>Issue Tracking: Balancing Ratio Determination</u>



# 3. Quadrennial Review

Mr. Jeff Bastian, PJM, reviewed package polling results from the survey sent on July 31. The committee voted on 4 packages.

The Committee did not endorse Package A (PJM) with 75 (39%) in favor, 115 (61%) opposed, and 22 abstentions.

The Committee did not endorse Package B (IMM) with 20 (10%) in favor, 186 (90%) opposed and 17 abstentions.

The Committee endorsed Package C (Calpine) with 170 (77%) in favor, 51 (23%) opposed and 14 abstentions.

The Committee did not endorse Package D (OPC-D) with 20 (10%) in favor, 185 (90%) opposed and 15 abstentions.

All 4 packages will be voted again at the August MRC.

Mr. Hal Loomis, PJM, presented draft tariff language to remove an apparent overlapping credit reduction provision for Qualified Transmission Upgrades, to clarify milestone documentation requirements for internally financed projects, and to clarify that Capacity Market Sellers should submit requests for reductions. The committee will be asked to approve the tariff language at the next MIC.

# 6. Transmission Constraint Penalty Factor

Mr. Angelo Marcino, PJM, provided a first read of the joint PJM/IMM package developed at the Special MIC Sessions to address the Transmission Constraint Penalty Factors issue. The committee will be asked to vote on this package at the next MIC. <u>Issue Tracking: Transmission Penalty Factor</u>

# 7. FERC Order 831 – Offer Caps

Ms. Susan Kenney, PJM, presented draft manual language that describes the long term automated process for Price-Based Offers greater than \$1,000/MWh. The committee will be asked to endorse the manual changes at the next MIC.

Ms. Gabrielle Genuario, PJM, reviewed updates to Manual 15 as part of the Biennial Review. The committee will be asked to endorse the Manual language at the next MIC.
