#### Administration (9:00-9:05)

1. Rebecca Carroll, PJM, provided a welcome and announcements.

Rebecca explained that to allow Brattle to present all analyses for Gross & Net Cone, VRR Curve and E&AS Offset at the same time, the decision was made to shorten today's Quadrennial Review Meeting. An additional meeting on March 25, 2022 has been scheduled at which Brattle will present, for the final time, all of their analyses prior to their report publication. In addition, the May 4, 2022 meeting has been cancelled and PJM will present their position at the May MIC. Based on stakeholder feedback, PJM will also look for additional meeting time in June and July.

Nikki Militello, PJM reviewed the Antitrust, Code of Conduct, and Public Meetings/ Media Participation Guidelines. The committee approved the draft minutes from December 8, 2021 Special Session.
