Administration (9:00 – 9:05)

Amanda Martin reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the May 10, 2023 Market Implementation Committee by acclamation with 0 objections and 0 abstentions.

1. Foluso Afelumo noted that the periodic review of Manual 6: Financial Transmission Rights was completed as identified in the 2023 MIC Work Plan. Manual 6 remains up-to-date and did not require any revisions.

2. Reactive Power Compensation Task Force (9:05 – 9:35)

Greg Poulos, CAPS, presented a proposed amendment to the Reactive Supply and Voltage Control Compensation Issue Charge. Greg Poulos, representing Illinois Citizens Utility Board, moved the motion and Art Iler, Indiana Office of Utility Consumer Counselor, seconded.

The committee did not approve this amended Issue Charge with 84.6% against and 15.4% in favor.

3. Interconnection Process Reform Manual Revisions (9:35 – 10:05)

Heather Reiter presented conforming revisions to Manual 6: Financial Transmission Rights, Manual 18: PJM Capacity Market, Manual 27: Open Access Transmission Tariff Accounting, and Manual 28: Operating Agreement Accounting as part of the Interconnection Process Reform. The committee will be asked to endorse the revisions at its next meeting.

4. Capacity Offer Opportunities for Generation with Co-located Load (10:05 – 11:05)

- a. Bruce Campbell, AEMA, provided a summary of the AEMA package.
- b. Sharon Midgley, Exelon, provided updates to the Exelon Package.
- c. Tim Horger presented a summary and comparison of all packages.
- d. Foluso Afelumo lead a discussion on next steps for the issue. An additional IMM package was posted following the meeting to reflect the “with service from the system” configuration.

The committee will be asked to approve packages at its next meeting.

The committee will be presented with two votes. One vote will gauge support for packages “with service from the system” and the second vote will gauge support for packages “without service from the system.” The different configurations are noted in the packages matrix.
