Administration

Lisa Drauschak and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Chen Lu provided an overview of the recent decision issued by the US Court of Appeals for the Third Circuit which vacated a portion of FERC's acceptance of PJM's request to adjust the 2024-25 Base Residual Auction parameters for the DPL South zone.

Endorsements

1. Governing Document Clarifying Revisions

Michele Greening reviewed proposed clarifying Tariff, Reliability Assurance Agreement (RAA), and Operating Agreement (OA) revisions addressing interconnection process references as endorsed by the Governing Documents Enhancements and Clarifications Subcommittee (GDECS) in February. Following discussion, the proposed revisions were **endorsed** by acclamation with no objections and 20 abstentions.

2. Demand Response Availability Window

Bruce Campbell, on behalf of DR Providers, reviewed a proposed Problem Statement and Issue Charge addressing the alignment of demand response capacity availability hours with periods of reliability risk. The proposed Issue Charge Key Work Activity (KWA) 2 contained a solution (using the Quick Fix process outlined in Manual 34, Section 8.6.1) to adjust the DR availability hours for the 2024-25 winter, while other KWAs proposed investigating further solution opportunities.

Sponsors of the Issue Charge withdrew their request for a vote to approve it at this meeting, indicating they may request approval at a future meeting.

3. Manual 18B: Energy Efficiency Measurement & Verification

- A. Pete Langbein reviewed the Main Motion of proposed revisions to Manual 18B: Energy Efficiency Measurement & Verification addressing Energy Efficiency resources.
- B. Ken Schisler, CPower, moved, and Manuel Esquivel, Enel, seconded an Alternate Motion of proposed revisions to Manual 18B: Energy Efficiency Measurement & Verification.
- C. Luke Fishback, Affirmed Energy, moved and Doug Hurley, Ictec, seconded an Alternate Motion of proposed revisions to Manual 18B: Energy Efficiency Measurement & Verification.

Following discussion, the proposed revisions contained in the main motion were **failed** in a sector weighted vote with 2.539 in favor. The revisions proposed by CPower **failed** in a sector weighted vote with 1.909 in favor. The revisions proposed by Affirmed Energy **failed** in a sector weighted vote with 1.575 in favor.

Erik Heinle, Vistra moved, and Paul Sotkiewicz, JPower, seconded an alternate motion consisting of the main motion, altered to include a transition for Technical Resource Manual validity (TRM) implementation as follows (revised sections of Manual 18B):

7a.1 Option A (Default): State or Region Technical Reference Manual

The most current State or regional technical reference manual, issued within 5 years of the installation period for the start of the 25/26 DY, 4 years of the installation period for the start of the 26/27 DY, and 3 years of the installation period for the start of 27/28 DY and for any DY going forward, of the install period and applicable to the location where the Energy Efficiency measure was installed. If there is no applicable state or regional technical reference manual, then Option B shall be used. ~~If there is no applicable state or regional technical reference manual to determine the baseline then Option B shall be used.~~

Following discussion, this alternative **failed** in a sector weighted vote with 3.325 in favor.

4. Capacity Obligations for Forecasted Large Load Adjustments Issue Charge

Michael Cocco, Old Dominion Electric Cooperative, moved and Rory Sweeney, Northern Virginia Electric Cooperative, seconded proposed amendments to the Capacity Obligations for Forecasted Large Load Adjustments Issue Charge currently being addressed at the Market Implementation Committee. Following discussion, the proposed Issue Charge was **approved** by acclamation with no objections and one abstention.
