#### Administration

Mr. Wallin also notified the OC that PJM has sent a solicitation letter to targeted Load Serving Entities (LSEs) to identify and report Non-Retail BTMG located in the wholesale area that a LSE serves. LSEs have been requested to complete and submit a Non-Retail BTMG report template to <u>BTMG@pjm.com</u> by July 31, 2019. PJM will continue to solicit stakeholder feedback regarding the Non-Retail BTMG report template.

Mr. Dave Souder, PJM, notified the OC that the Non-Retail BTMG subgroup activities were complete and that no further meetings would be held prior to the endorsement vote. The Operating Committee will be asked to endorse the proposed changes at the next OC meeting.

- 2. Manual 10 endorsement vote will be deferred until the Modeling Units with Stability Limitations Problem Statement and Issue Charge is addressed by the MIC.
