SOS Joint - eDART

eDART Browserless Refresh Update

- Phase 1, transition to PJMCLI, is expected to be completed March 31 in Train
- Details discussed during March eDART XML Forum. Materials available at <u>https://pjm.com/committees-and-</u> groups/forums/edart-forum.aspx
- Production deployment of Phase 1 scheduled for **April 14**.
- Phase 2 = Minor enhancements and fixes; expected to be completed Q2 2021
- An updated User's Guide and training will be provided for each phase
- The filetransfer.jar and legacy URLs will be retired in December 2021

Dynamic Line Ratings Enhancements

- Discussed during the <u>3/30/2021 OC</u> <u>Special Session</u>
- Enhancements to eDART to handle DLR:
- Ability for Transmission Owners with DLRs to upload and download forecasted ratings (CSV format)
- Files to be added to Ratings Information page on <u>OASIS</u>
- Dynamic Line Ratings Forecast (zip file with latest uploaded forecasted ratings)
- Historical Ratings (zip files with Ratings, Temporary Ratings and Dynamic Line Ratings Forecast per company)
- Implementation Timeline: May-June 2021

Other Discussion Topics

- Conversion of eDART files (.txt and .csv) available on pjm.com to zip files in July 2021.
- Conversion to zip files will reduce the data transfer size for users.
- Files are available via the Public Files report in eDART.
- Information in some of the files also available via XML downloads in eDART.

2021 Annual Voltage Schedule Review

- The eDART Voltage Schedule Annual Review function allows PJM to initiate a review of all applicable voltage schedules once a year.
- The 2021 Annual Voltage Schedule review was initiated on April 1, 2021, and will remain open through April 30, 2021.
 - TO Review Phase (April 1 April 30, 2021): TOs to review and acknowledge accuracy of all active voltage schedules, and submit updates where necessary.
 - GO Review Phase (May 1 May 31, 2021): GOs to review and acknowledge awareness of all active voltage schedules, and ensure their application in the respective generating facilities.
- This function also allows tracking of the TO and GO acknowledgements for each active voltage schedule reviewed during the process.
