2. <u>PJM COVID-19 Update</u>

Paul McGlynn, PJM, provided an update on PJM's operations plan in response to COVID-19. <u>https://pjm.com/committees-and-groups/pandemic-coordination.aspx</u>

A. Paul announced that the PJM Manual 1 Attachment F, (PJM's guidance for Market Operations Centers to conduct remote operations during the COVID-19 Pandemic) set to expire on June 30th, 2021 has been extended through December 31, 2021.

It was requested by stakeholders to not sunset Attachment F and to instead expand Attachment F to include other triggers for when a member may need to go to a remote MOC operation. PJM will draft proposed changes to the Attachment F language and bring back to the OC at a future date (prior to the December 31, 2021 expiration date).

3. Review of Operating Metrics

Stephanie Monzon, PJM, reviewed the May 2021 PJM operating metrics slides. Metrics included PJM's load forecast error, BAAL performance, and transmission / generation outage statistics.

It was requested that future presentations include a slide detailing shortage cases from the month in review.

Code of Conduct:


