- 1. Dave Souder, PJM, called the meeting to order and Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
- 2. Molly Mooney reviewed the July 7, 2020 Planning Committee Agenda. An announcement was made regarding two upcoming training sessions for Pre Queue and Post ISA education sessions. No changes to the agenda were requested.
- 3. Molly Mooney reviewed the draft minutes posted for the June 2nd, 2020 meeting and the Planning Committee approved the minutes.
- 4. Molly Mooney reviewed the Planning Committee Work Plan through the first two quarters of 2020. A request was made to provide more granularity on the task ending dates.

5. PMU Placement in RTEP Planning Process

Shaun Murphy, PJM, reviewed the problem statement, issue charge and proposed solution to address PMU requirements in the RTEP planning process. After stakeholder discussion, the committee voted on the issue charge and proposed solution. The committee approved the PMU Placement in RTEP Planning Process Issue Charge and the proposed solution to address this issue as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 with a vote of 136 Yes (89%), 16 No (11%), 17 Abstain.

6. Load Model Selection

Patricio Rocha-Garrido, PJM, presented the results of the Load Model selection process for the 2020 Reserve Requirement Study. The committee will be requested to endorse this Load Model selection at the August PC meeting.

- Dynamics PJM will request dynamic load models and dynamic device models from the TOs for SVCs, STATCOMs, synchronous condensers and FACTs devices on Monday July 13, 2020; to meet their MOD-032 obligation, the TOs will provide requested models by Friday September 25, 2020. PJM will submit dynamics data to Powertech by Friday September 4, 2020.
