Current PJM Minimum Capitalization Requirements

Minimum Capitalization Requirements include a net tangible asset or tangible net worth threshold:

- FTR participants must demonstrate a tangible net worth in excess of \$1 million or tangible assets in excess of \$10 million
- Other Market Participants must demonstrate a tangible net worth in excess of \$500,000 or tangible assets in excess of \$5 million
- If a Market Participant* does not demonstrate compliance with the Minimum Capitalization Requirements, it may still qualify to participate in any PJM Markets by posting Collateral, additional Collateral, and/or Restricted Collateral.
