Antitrust, Code of Conduct and WebEx Instructions

Antitrust:

If any of these items are discussed the chair will re-direct the conversation. If the conversation still persists, parties will be asked to leave the meeting or the meeting will be adjourned.

Code of Conduct:

As a mandatory condition of attendance at today's meeting, attendees agree to adhere to the PJM Code of Conduct as detailed in PJM Manual M-34 section 4.5, including, but not limited to, participants' responsibilities and rules regarding the dissemination of meeting discussion and materials.

PJM may create audio, video or online recordings for internal and training purposes, and your participation at such meetings indicates your consent to the same.
