### MSRS Refresh – May 20 release (1.0.4)

- New Features
  - Reports Tab
    - Added a maximum of 15 Custom Categories per User with the ability to add an unlimited number of reports to each of those Custom Categories
  - Miscellaneous
    - Download a maximum of 25 reports at a time on the Billing Details, Reports, and Download List tabs
    - Added a download progress bar on the Billing Details, Reports and Download List tabs



#### MSRS Refresh – May 20 release (1.0.4)

- Existing Feature Improvements
  - Billing Details Tab
    - Sorting and filtering has been removed from the Net Total table
  - Reports Tab
    - The start/end dates selected on the date picker will match the start/end dates that populate in the table
    - The Category field will reflect the primary category for each report
  - Download List Tab
    - Remove table formatting distortion when reports are added

- Retire legacy MSRS in Production: mid-July 2021



**Product Details** 

 Market Settlements Reporting System (MSRS) is a tool used by Market Participants to retrieve market settlements reports and monthly billing statements.



**Project Goals** 

- Improve browser compatibility
- Create consistent User Interface (UI) look and feel, similar to other PJM Tools applications
- Create supportable framework for PJM development staff to manage new report development and changes
- Implement standard token based security for authentication.
  - This is a requirement for access of the refreshed MSRS application



**Project Goals** 

- Maintain current Single User Multi Account (SUMA) capability
- Improve report request performance
- Support enhanced functionality
- Minimize impact to users for browserless report requests
  - Maintain API protocols and standards





- Token based authentication will replace the current basic authentication
  - Consistent authentication protocol with other PJM Tools applications
  - It is recommended members begin using SUMA once this transition is made to reduce account management time and certificate cost. This work can begin immediately.

  - Token based authentication is mandatory to utilize the refreshed MSRS
- Reports will not be viewable on the current UI with the exception of billing invoices



Impacts to Members

- Reports can still be downloaded in CSV, XML, and PDF formats through the UI
  - PDF format applies to billing invoices
  - PDF format will be slightly modified, but with same data content
- UI pages will be redesigned
  - New landing page
  - Enhanced shopping cart functionality
