As of June 11, 2021

- Upcoming change to Real Time Values (RTV) – FERC rejected PJM’s filing. Changes on hold until further notice
- Added informational slide regarding Browserless API Two-Factor Authentication.

- Real Time Values (RTV) process - For Resources to communicate their current operational capabilities when the resource cannot operate according to the unit specific parameters (CP and uncommitted capacity) or exceptions based on a physical constraint.
- PJM found that, at times, RTVs have been used for reasons outside of the original intent (to communicate actual constraints), or have not been updated and so can cause reliability issues. Therefore, PJM will be limiting RTVs to 24 hours (one operating day)
- The change:
  - When an RTV is requested it will be available for one day, then the schedule will revert to the relevant parameter values prior to the submission of the RTV (for the entire schedule). (On Parameter Limits > Exception page)
  - Market Participants will need to be aware that their schedule from the day that has the RTV will not roll forward and RTVs will need to be entered each day they are needed. (On Generator > Schedules > Detail page)

- Notice:
  - Market Participants with a multi-day RTV submittal that extends beyond June 1, 2021 will need to withdraw this RTV submittal, or modify the end date to terminate on June 1, 2021.
- Important dates:
  - Train availability – May 19
  - Production availability – FERC rejected – On Hold

- Applications will have API Two-Factor Authentication Opt-in turned on.
- Once opted in, the user is required to provide a valid PKI certificate for
  - Markets Gateway
- When:
  - Train – June 14
  - Production – July 15
- The mandatory cut-over will take place in Q1 2022
