- Move Search engine to Cloud – March 2023
- Hardware updates – January 2024
- Network adjustments – February 2024
- Refactor PJM.com home page – April 2024
- Move PJM.com and its sub-sites to cloud – In progress (December 2024)
- Upgrade software to the latest version – In progress (December 2024)
- Refactor code base – In progress (June 2025)
- Measure performance metrics – Ongoing

Improving PJM.com performance is a long-term initiative with many variables due to the complexity and size of the website.

Status:
Page loading speeds continue to improve.

- Scripts written to scrape data from **PJM charts** on the homepage and Markets and Ops page will no longer function.
- The data source for **the charts on the homepage** of www.pjm.com and **Markets and Ops page** is Data Miner.
- Scripts written to retrieve documents from the website should continue to work.

After the move to Cloud:

Underlying page technology will be gradually upgraded across the website. The organization of the site will remain the same.

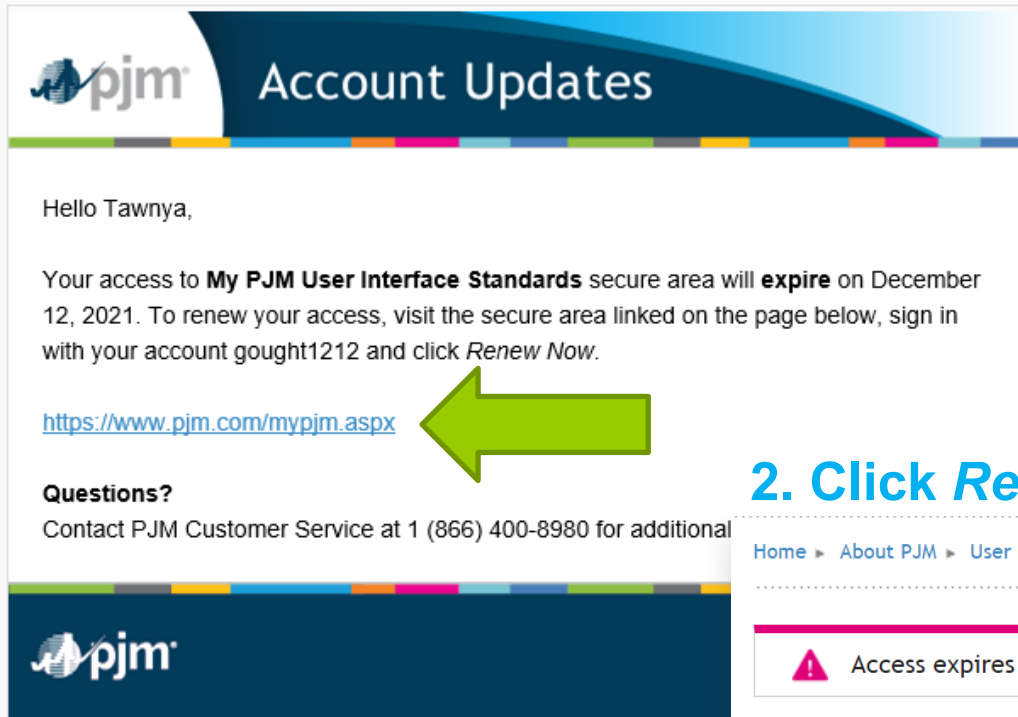

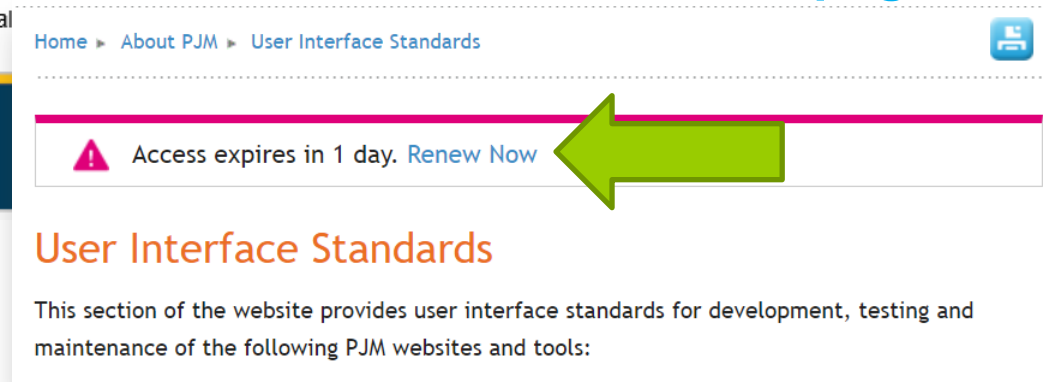
- Access expiration policy for Members:
