Administration (9:00 – 9:20)

1. Scott Baker opened the meeting and reviewed the agenda.
2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from the March DIRS meeting and the EDC coordination workshop were approved with 0 objections and 0 abstentions
3. Scott Baker reviewed the DIRS work plan.
 - Scott reviewed the detailed work plan for FERC order 2222 briefly discussing different milestones. Scott highlighted that today's DIRS meeting will be mostly spent walking through PJM's straw proposal for DER aggregation under FERC order 2222.
4. Thomas DeVita addressed FERC's Order 2222-A, which provides clarification on a number of issues contained in Order 2222.
 - Thomas reviewed key item topics from FERC order 2222-A.

Order 2222 – Discussion on straw proposal (9:20 – 3:00)

5. Scott Baker introduced a solutions matrix that will be used to track progress on PJM's compliance filing as well as compare policy options for certain topic areas.
 - Scott reviewed the status quo matrix for high level requirements within FERC order 2222 and indicated that PJM intends to use the matrix for tracking its compliance proposal moving forward.
6. PJM Staff reviewed a straw proposal for DER Aggregation that seeks to address the various compliance directives in Order 2222. The straw proposal was meant to provide a more holistic view of how PJM staff is initially approaching each topic area, and to serve as a starting place for further collaboration between staff and stakeholders on PJM's compliance filing.
 - Danielle Croop, PJM, provided an overview of PJM's high-level holistic design approach and additional areas that require further discussion. Danielle also reviewed the new extension timeline highlighting that PJM has not received feedback from FERC regarding the February 1, 2022 extension.
 - Danielle briefly discussed PJM's guiding principles for design development and compartmented FERC order 2222 into five designs; DERA Jurisdiction and Interconnection, Operations, Market Design, Settlements and Coordination. Danielle also reviewed various terminologies.
 - Sue Glatz, PJM, discussed FERC's guidance towards interconnection stating that FERC elucidates in the order that DER engaging in wholesale market activity through a DER aggregation do not fall under a Commission Jurisdictional interconnection.

- Sue discussed capacity interconnection rights (CIRs), status quo for retail connected BTM DERs and concerns with expanded DER participation and continued use of netted generation model. Sue also reviewed proposed data requirements for planning and analyzed a simplified example of netted and aggregated modeling.
- Thomas DeVita, PJM, discussed PJM's reasoning on Jurisdiction, discussing Market-Based Rate Authority, Market Participation Agreements and opt-in small utility.
- Danielle Croop, PJM, discussed location requirements for DER aggregations. Danielle also indicated that each DER will be mapped individually in PJM network. Danielle also reviewed nodal aggregations, weighting factors and various locational requirements definitions and discussed numerous examples.
- Maddie Beban, PJM, discussed zonal aggregation model and telemetry.
- Danielle Croop, PJM, discussed PJM's direction towards operational needs and reviewed Capacity, Energy, cost based offers and Ancillary services within the Market participation model.
- The group ran out of time to finish the entire proposal presentation and will pick up at the next full-day DIRS within the Size Requirements section of the presentation.

Solar-Battery Hybrid Resources (3:00 – 3:55)

7. Andrew Levitt, PJM, provided education around a synchronous reserves requirement for hybrids.
 - Andrew discussed primary and uncertainty considerations for Synchronized Reserve for solar-battery hybrids and reviewed language within PJM manual 11 regarding Synchronized Reserve.
8. Skyler Marzewski, PJM, provided an update on the application of the Minimum Offer Price Rule for co-located and hybrid resources.
 - Skyler discussed MOPR prices, MOPR for hybrid resources and co-located resources for Solar plus Battery. Skyler also reviewed MOPR decision tree for Solar plus Battery.
9. Stakeholders reviewed progress on the solar-battery hybrid solutions matrix and discussed next steps towards recommending a proposal to the MIC (and OC).
 - The group did not have time to review the matrix but agreed to work offline to see if the current two proposals could be narrowed to a single proposal by the next meeting.
